NOTE ON RECORD-KEEPING

Formal monthly bookkeeping was not consistently maintained during the company's first year of operations (February–December 2025). Based on the Founder's recollection, monthly net profit from the Retail & E-commerce business is believed to have ranged approximately BDT 10,000 to BDT 18,000. These figures are estimates, not audited records, and are disclosed here transparently rather than presented as precise data.

Corrective Action:

The company is reconstructing exact figures from available bank and mobile financial service statements where possible, and has begun implementing formal monthly bookkeeping to ensure all future reports reflect verified, audited figures.
